OVERVIEW

BUYER'S MARKET

The [Puslinch](#) real estate market remained firmly in buyer-friendly territory, as a significant pull-back in buyer activity continued to outweigh available inventory. The median sale price declined 17.78% to \$1.30M, while the average sale price fell 8.08% to \$1.30M. Sales volume dropped sharply by 63.23% to \$2.59M, driven by unit sales decreasing 60% to just two transactions. While new listings decreased 25% to 15, and expired listings fell 58.33% to five, the slow pace of sales continued to expand buyer choice. With a unit sales-to-listings ratio of 13.33%, down 11.67% year over year, conditions clearly favoured buyers in the Puslinch market.








Month-Over-Month 2025 vs. 2026





SALE PRICE VS. LIST PRICE RATIO






DOLLAR VOLUME SALES



Monthly Comparison 2025 vs. 2026




Yearly Totals 2025 vs. 2026




UNIT SALES



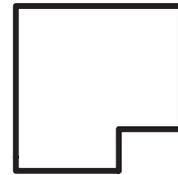


